Act No. 95, 1977

SOUTH WEST AFRICA CONSTITUTION AMENDMENT
ACT, 1977.**ACT**

To amend the South-West Africa Constitution Act, 1968, so as to extend, with a view to the regulation of additional matters, including the administration of Walvis Bay, and the eventual attainment of independence by the territory of South West Africa, the powers of the State President to make laws for the said territory; and to provide for matters connected therewith.

(Assented to 20 June 1977.)*

BE IT ENACTED by the State President, the Senate and the House of Assembly of the Republic of South Africa, as follows:—

1. Section 38 of the South-West Africa Constitution Act, 1968, is hereby amended—

(a) by the substitution for subsection (1) of the following subsection:

“(1) The State President may by proclamation in the *Gazette* make laws for the territory with a view to the eventual attainment of independence by the said territory, the administration of Walvis Bay and the regulation of any other matter and may in any such law—

(a) repeal or amend any legal provision, including this Act, except for the provisions of subsections (6) and (7) of this section, and any other Act of Parliament in so far as it relates to or applies in the territory or is connected with the administration thereof or the administration of any matter by any authority therein; and

(b) repeal or amend any Act of Parliament, and make different provision, to regulate any matter which, in his opinion, requires to be regulated in consequence of the repeal or amendment of any Act in terms of paragraph (a).”;

(b) by the substitution for subsection (2) of the following subsection:

“(2) If any authority is by any law made in terms of subsection (1) empowered to make laws, a law made by any such authority by virtue of that power, shall not be of force and effect until it has been approved by the State President.”.

2. This Act shall also apply in respect of the Eastern Caprivi Zipfel.

3. This Act shall be called the South West Africa Constitution Amendment Act, 1977.
