#### ANNEXURE.

### ACT

To provide for the registration of women as voters and for their voting in the election of members of the House of Assembly and Provincial Councils, and for their capacity to be nominated, elected and to sit and vote as Senators, Members of the House of Assembly or of Provincial Councils.

> (Assented to 19th May, 1930.) (Signed by the Governor-General in English.)

BE IT ENACTED by the King's Most Excellent Majesty, the Senate and the House of Assembly of the Union of South Africa, as follows:-

### Act No. 18 of 1930.

Enfranchisement of women and their registration as voters.

- 1. Notwithstanding anything to the contrary in any other law contained every woman who--
  - (a) is a Union National;
  - (b) is of or over the age of twenty-one years;
  - (c) is not subject to any of the disqualifications mentioned in section two,

shall, at and as from the first biennial registration of voter under Chapter I of the Electoral Act commenced after the coming into operation of this Act, be entitled to be registered as a voter under the provisions of the first mentioned Act and to vote at any election held after the coming into operation of the voters' lists revised after the said registration in any division in which she is registered as a voter.

Disqualification.

- 2. No woman shall be entitled to be registered as a voter-
  - (a) if she has been convicted in the Union of treason or of murder unless she has obtained a free pardon; or
  - (b) if she has been convicted in the Union of any offence and sentenced to imprisonment without the option of a fine, which imprisonment shall not have expired at least three years before the commencement of any registration in which she claims to be registered, unless she has obtained a free pardon.

Women voters not to affect delimitation. 3. At any delimitation of electoral divisions carried out after the commencement of this Act under sections forty-one forty-two and seventy-one of the South Africa Act, 1909, women who are registered as voters shall not be taken into account in the re-division of any province into electoral divisions.

Women as legislators.

- 4. (1) A woman shall not be disqualified by sex or marriage for being nominated, elected or for sitting or voting as a Senator or Member of the House of Assembly or of a Provincial Council.
- (2) For the purposes of paragraph (e) of section twenty of the South Africa Act, 1909, a woman married in community of property shall be deemed to be the registered owner of any immovable property registered in the name of her husband.

Interpretation of terms.

- 5. In this Act-
  - "Electoral Act" means the Electoral Act, 1918 (Act No. 12 of 1918), as amended from time to time; and any expression to which a meaning has been assigned in that Act has, when made in this Act, the same meaning.
  - "Woman" means a woman, who is wholly of European parentage, extraction or descent.

Short title.

6. This Act may be cited as the Women's Enfranchisement Act, 1930.
